- Efficiency Boost: Customers below the maximum monthly income range on the table are eligible for higher rebates through PSE's Efficiency Boost program.
- Standard rebates: If your monthly income is above the max level indicated on the table, please apply for PSE's standard, everyday [rebates](#).

Note: Income includes all gross wages, tips, rental income, public assistance, social security or pensions, income from self-employment, alimony, interest or any other sources of income defined by the IRS income tax return.
