Prices, terms and conditions

Puget Sound Energy's Green Power Program is certified by Green-e Energy which requires participating utilities and companies to provide their customers with this notice of Price, Terms and Conditions for this service. The amount of your selected green power purchase will be added to your PSE electricity bill each month until you discontinue your participation. How will I be billed?

Your selected green power purchase amount will be listed as a separate line item on your monthly PSE electricity bill.

How will my bill be calculated?

Customers who choose to purchase blocks of green power must purchase a minimum block of \$4 a month, which allows PSE to buy 400 kilowatt hours (kWh) of energy on your behalf. You can choose to purchase additional green power blocks of 200 kWh at \$2 each. The green power charge will appear on your bill and is in addition to your monthly electricity bill. Customers who select the 100 percent green power option will be charged 1 cents per kWh on top of your monthly electricity charge. With the 100 percent option, your monthly green power charge is dependent on your monthly electricity usage. You must also pay all applicable federal, state, and local taxes and charges.

How much will my total electricity service cost, including utility charges?

Customers who participate in the block option will pay their normal monthly electricity charge plus the block option amount of their choice. For example, if—in a given month—your electricity charge is \$53 and you have selected a \$4.00 block of green power, then your monthly charge will be \$57 that month. Customers who participate in the 100 percent Green Power option will be charged an additional 1 cents multiplied by their actual monthly kWh electricity usage. For example, based on a monthly average usage of 1,000 kWh, the following table provides an estimate of a monthly electricity bill if you purchase 100 percent green power. Your actual bill will vary based on your use of electricity.

Will my rates change over time?

Utility service rates are subject to change over time. All rate changes require approval from the Washington Utilities and Transportation Commission. Customers will be notified within one-month of a green power rate increase or decrease.

What sources will be used in my certified product?

If I want to terminate this agreement/contract, is there an early termination fee?

There is no termination fee. You may discontinue your participation at any time.

What length of agreement/contract is required?

You may discontinue your participation in PSE's Green Power Program at any time.

What other fees might I be charged?

There are no additional fees associated with PSE's Green Power Program.

Historic figures reflect the power delivered to the PSE Green Power Program's customers in 2015.

2. New Renewables come from generation facilities that first began commercial operation within the past 15 years. This product includes generation from a facility that is approved under a strict set of criteria as repowered.

3. Eligible hydroelectric facilities are defined in the Green-e Energy National Standard (www.green-e.org/getcert_re_stan.shtml) and include facilities certified by the Low Impact Hydropower Institute (LIHI) (www.lowimpacthydro.org) or EcoLogo (www.ecologo.org); and facilities comprised of a turbine in a pipeline or a turbine in an irrigation canal.

For comparison, the current average mix of resources supplying PSE includes: Hydroelectric (36%), Coal (35%), Natural Gas (24%), Wind (3%), Nuclear (1%), and Other* (1%). *Biomass, landfill gas, petroleum and waste.
